### **Reminder to Xero Clients with BNZ Bank Accounts**

BNZ has been working with Xero to simplify the way bank feeds are setup, and to help improve access to transaction data.

Bank feeds are now set up and connected automatically within Xero. This replaces the paper form set-up process.

If you already share your BNZ banking information with Xero, you'll need to switch to the new feeds.

#### How to switch

Xero or HC Partners will have sent detailed instructions on how to switch, to the primary Xero subscriber in your organisation.

If you have updated your connection you will need to log in to Xero then:

- select 'Update bank connection' which will direct you to the secure BNZ login page
- enter your BNZ access number and password
- authorise and confirm the information you agree to share with Xero
- check that the right bank accounts have been selected in Xero, and set up import start dates for your bank feeds for each bank account.
